- **Industrial and bare floors:** removes set-in grease, oil stains, tyre tracks and sludge from all types of non-fragile floors.

Dosage and Instructions for Use

Manual cleaning: 1-5% (80-400 ml for 8 litres of water) based on how dirty the material is. It is recommended to soak materials which are very dirty for 5 to 30 mins, depending on the type of dirt on them.

Machine: 0.5-2.5% in scrubber-dryers, single-disk scrubbers, high and low pressure sprayers.
Rinse the tank after applying the product.

Can be diluted in cold or warm water, but not in hot water as there is a risk of corrosion.

Renovating sports floors: scrubber-dryer: 2.5%, common use: 1%
