### **Applications**:

**Le VRAI PROFESSIONNEL HEAVY DUTY DESCALER** can be used after construction or renovation to remove cement traces, plaster residue and limestone deposits. It is suitable for all types of indoor and outdoor tiling. Also, its water-repellent action effectively removes rust marks on these materials.

**Le VRAI PROFESSIONNEL HEAVY DUTY DESCALER** can also be used for cleaning toilets and showers, maintaining public swimming pools, and cleaning changing rooms and bathrooms in sports halls and gymnasiums.

### **Instructions for use:**

Dilute 10-50% of product in a bucket of water (or 80-400 cl in an 8 litre bucket), depending on the level of dirtiness of the surfaces. Apply the solution generously over the floor or surfaces. Let stand for 5-15 minutes. Scrub with a brush. Rinse thoroughly. Repeat the application, if necessary. Do not use le VRAI PROFESSIONNEL HEAVY DUTY DESCALER on acid-sensitive materials (marble, limestone).
